Electronic Communications Advisory Committee

NARFE'S Electronic

Communications Advisory Committee (ECAC) was formed in the latter part of 2004, at the request of National President Charles Fallis. The ECAC directly replaces NARFE'S former National Communications Advisory Committee (NCAC). Each of these groups has been instrumental in maintaining the lines of electronic record data keeping for information retrieval and transmittal to the various Regions, State Federations and local Chapters via the Internet.

The ECAC is comprised of one committee member representing each of NARFE'S ten (10) Regions (appointed by the local Regional National Field Vice President at the recommendation of a Federation President). These members were selected for their knowledge and personal computer expertise, being active in their Chapter and Federation and having technologically contributed to the growth of NARFE'S family of Federation Web Sites, as well as individual Chapter Web Pages.

Many hold the title of Federation Net-Coordinator as they maintain these Web Sites. One is appointed Committee Chairman and interfaces with a member of the National Executive Board (NEB). To date, the ECAC has successfully interfaced with NARFE'S Support Services and Information Technology (IT) staff members and employees of Interactive Systems, Inc., a computer outsource

company (which maintains all of NARFE'S massive record keeping), in establishing a working dialogue of agreed-upon monthly (i.e., M-112 and semi-annual M-114) Report *formats* for user-friendly downloading on your own Personal Computer (PC).

It has also prompted the IT staff to make some cosmetic, as well as beneficial, changes to our National Web Site and suggested ways to better utilize the GEMS informational internet system in order to maintain closer contact with members who have registered their internet address with headquarters.

The ongoing list of the ECAC'S suggested changes is virtually endless in our quest for achieving electronic communications excellence. Any suggestions for improvement of any report data retrieval, Internet site maintenance/updates, or other form of effective communications, on a Chapter level, are gladly entertained. I would be pleased to forward your concerns via the ECAC for any future consideration.

NARFE SC Federation 2007 Convention

The SC Federation Executive Committee met on June 12th and voted to hold the 2007 state convention in Columbia with Chapter 87 serving as the Host Committee in close coordination with the Federation officers. Kathy Hensley, who has extensive convention planning, has been appointed Convention Chair. The initial planning stage is underway with great response from the Chapter 87 members.

During the next week, a location will be selected. The convention will be held during April 2007. Federation President Margaret Baptiste is providing leadership to make the conference program meaningful and interesting. As additional information becomes available, it will be published in newsletters, appear on the web site and will be distributed to the chapters around the state.

2007 COLA for Retirees Continues To Go Up

On July 19th, the Labor Department's Bureau of Labor Statistics (www.bls.gov/cpi) reported the consumer price index for Urban Wage Earners and Clerical Workers, the CPI-W, for June is 198.6, up 0.2 percent from the May index of 198.2. For purposes of calculating the next COLA (cost of living adjustment), June's index is 3.1 percent higher than the third quarter average base index in 2005 (192.7).

In 2006, the COLA for federal retirees was 4.1%--the largest increase in more than a decade.
